Federal Programs

• The Elementary and Secondary Education Act (ESEA) requires equitable services be provided to private school students, teachers, and parents.

• Why? Federal programs are supported by tax dollars, so <u>all</u> children and teachers are eligible to access these programs.

Federal Programs

- District must conduct an annual English Learner and Migrant meeting with all stakeholders prior to submitting their annual federal grant application .
- District maintains administrative control over services.
- District regularly monitors teachers and providers who deliver services.

Title I, Part A

Title I, Part A (Title I) of the Elementary and Secondary Education Act, as amended (ESEA) provides financial assistance to local educational agencies (LEAs) and schools with high numbers or high percentages of children from low-income families to help ensure that all children meet challenging state academic standards.

Title I Eligibility

- > Non-Public School children who meet the same criteria for poverty used by the LEA and who live in a Title I attendance area are eligible for services under Title I.
- > Public schools determine eligibility using direct certification percentages from DSS.
- > Non-Public Schools must use the same measure of poverty as public schools.

Title II, Part A

Title II Part A is a federal program that provides funds to school districts including charter schools and state operated programs for supporting effective instruction.






Strategies for Parents

- Storytelling
- "Read" wordless picture books
- Say rhymes and sing songs
- Make frequent trips to the public library
- Engage in meaningful conversation
- Watch educational children's television programs together
- Read bilingual books and check for comprehension

- Conference with teachers
- Provide good work space
- Find a tutor
- After-school program /Saturday Academy
- Read and write daily
- Drill multiplication facts
- Drill phonic skills
- Visit the grocery store to identify prices, count money
- Monitor child's progress (report card, progress reports)

Two Weeks Prior to testing....

- 1. Allow your child to practice "endurance" reading. The reading portion of the EOG requires focus and stamina, as there are many passages and question to get through. If your child loves to read, he probably won't be stressed by this portion of the test. However, for children that have a hard time sitting down to read for ten minutes, push them to read for longer periods of time.
- 2. Ask your child questions about what they are reading. Try to get them to explain the plot and describe characters' actions, point of view, main topic/idea, and discuss unfamiliar words.
- 3. Encourage calculator use and make sure that your child is using the calculator appropriately to solve math problems. The calculator is only helpful if it is used correctly.
- 4. Review strategies for solving math problems. Pose a problem and see how many different ways your child can solve it. This encourages higher order thinking skills.


